

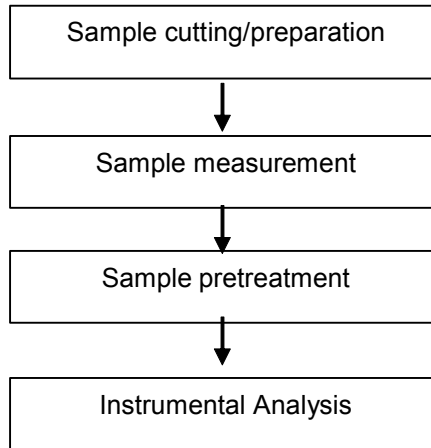

SVHC Testing Flow Chart



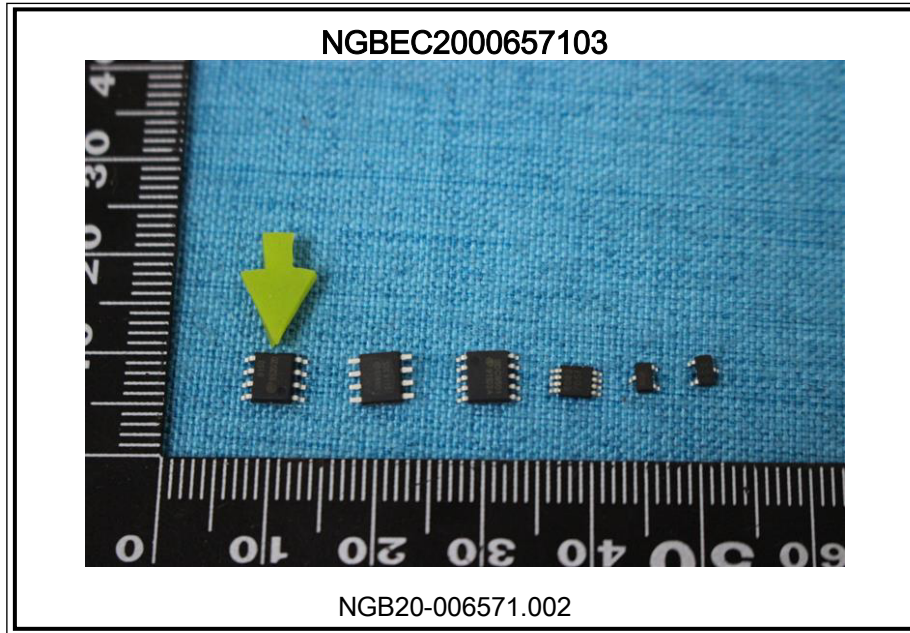
